New members must complete and submit the membership form and pay the relevant fee.

All applications to become a member have to be accepted and approved by the Directors and Trustees of The Swindon Food Collective at scheduled Board meetings where decisions to approve or disapprove will be recorded. This is in accordance with the organisation's Memorandum and Articles of Association.

This new membership year operates from 1st April 2019 to 31st March 2020 and we are now accepting applications. All membership fees are due by 1st April each year for the following year. All new memberships must be approved by the Board and fees received at least 5 working days before a General Meeting.

Each paid up member can submit one vote per tabled motion at any General Meetings of the organisation, either in person or by proxy.

A register of members will be kept by the organisation.
